LSA - REGISTRATION AND NUMBER ASSIGNMENT APPLICATION

This form is to be used to request the assignment of an RA-Aus registration number and registration for a Light Sport Aircraft. Submission of this form and assignment of a registration number by the RA-Aus registers the aircraft with RA-Aus but **DOES NOT ALLOW THE AIRCRAFT TO FLY**. Approval for flight is gained on receipt of a Certificate of Airworthiness suitable to the aircraft type.
AIRCRAFT MAY NOT BE FLOWN UNTIL A CERTIFICATE OF AIRWORTHINESS HAS BEEN ISSUED BY A CASA APPOINTED PERSON.
